What is this product?

Type

Ordinary shares in a company registered in the British Virgin Islands. 
What are the risks and what could I get in return?

What happens if Dolphin Capital Investors Limited is unable to pay out?

What are the costs?

Presentation of Costs

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account certain one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for different holding periods. They include potential early exit penalties. The figures assume you invest £10,000. The figures are estimates and may change in the future.
